# All Souls Church Unitarian Leadership Development and Nominating Committee Annual Report to the Congregation April 23, 2023

The Leadership Development and Nominating Committee (NC) is comprised of All Souls congregants who are charged with three core goals according to current bylaws:

- 1. Working with the Council, Board, and Executive Team to identify leadership gaps and recruit new leaders:
- 2. Managing the process for nominating trustee and officer candidates, striving to present a slate that reflects the diversity of the All Souls community; and
- 3. Overseeing leadership development by, among other things, providing training, workshops, and individual outreach.

Last year, after careful study of the responsibilities of nominating committees of other UU churches, we recommended a bylaws change to the Board of Trustees that would remove the broad task of leadership development from the domain of the NC. Consistent with this recommendation, this year's NC focused on recruiting the best possible slate to serve the congregation in leadership roles.

### 2023 Nominations

This year, the NC sought candidates for the following positions:

- Two board positions for 3-year terms
- Treasurer
- Assistant Treasurer
- Six NC members, four for 2-year terms and two for one-year terms.

We did not recruit a candidate for the position of Moderator because we understand that, if approved, the pending bylaws revisions will eliminate that position from the church's roster of officers.

A one-year NC position remains open. Please contact the NC if you are interested. NC service suits outgoing members who know or are willing to get to know a wide array of members across the various demographics that comprise our church and can objectively assess others' suitability for covenantal and fiduciary leadership roles.

Despite extensive outreach, both targeted and congregation-wide through church communications, we were not able to recruit a congregant for nomination to the Assistant Treasurer position. Pursuant to the bylaws, the Board may appoint a congregant to this position between annual meetings.

# **Recruiting and Nominating Trustees and Officers**

The NC's recruitment process is guided by All Souls' commitment to a multiracial and multigenerational community in leadership and membership. We evaluate candidates' service to the congregation, professional experience, skills and interests that are suitable to trustee service, and voting membership.

The NC is elected by and accountable to the congregation. However, while recruiting, we sought broad input from lay leaders, and staff, including the Executive Team. The NC also consulted with conveners of church affinity groups to identify prospective board members who reflect the racial, sex/gender, and generational diversity of the congregation as well as to identify members with varying experiences and backgrounds for the board. We also sought suggestions from the congregation by including a notice in the weekly bulletin, amplified during Sunday services.

While we strived to include BIPOC church leaders on the slate this year, we learned that many were unavailable for board service at this time, in part because of involvement on other church committees, including Rev. Sinkford's ministry team, the Transformative Justice Committee, the Search Committee, and Beckner Advancement Fund.<sup>1</sup> Several BIPOC leaders who could not serve as trustees this year expressed interest in doing so in the future.

Our slate this year includes talented and dedicated members who have served the church for many years: Alan Abramson, Brian Petruska, and Elizabeth Andrews Zitelli. We hope you will read their bios, below, and express your appreciation for them when you see them around church or in the zoom room.

Rob Keithan to consider whether the Fund (which largely makes grants to outside organizations) requires nine church members serving four-year terms to function effectively.

### **Nominees for Trustee**

The NC is pleased to present as nominees to the ASC board of trustees:

### Alan Abramson



Alan Abramson became a member of All Souls Church in 2002. At All Souls, Alan has served on the Beckner, fundraising, and nominating committees; taught religious education; ushered; and participated in service trips to New Orleans and North Carolina. In recent years, the All Souls Parents of Teens group has been an important part of Alan's life.
